Stamp News. WHILE full announcement of the 1938 U. S. stamp program is still awaited, reports on appointment of another Constitution commemorative will be issued June 21. It would mark New Hampshire's ratification of the Constitution on June 21, 1788, the ninth state to approve the document and thus the number required for full ratification. Adding to the list of U. S. Constitution Commemoratives, Dominican Republic has issued a series of three stamps. They portray a map of the western hemisphere, torch of liberty and a tablet marking the 150th anniversary of the great American charter. First to lead the world in marking the centenary of the American stamp is France. A commemorative issued reproduces the design of the original French stamp of 1849. The stamp invention really dates from 1838, although Great Britain issued the first one in 1840. It is believed many other countries will follow in this field. Sweden will issue a special set of stamps in March to mark the 200th anniversary of Swedish stamping in Delaware. Sweden will issue formal designs of the United States June 27 to be received on the spot where the Swedish colonists in 1783 first set foot on American soil. Interesting new issue: Straits Settlements six new "reign" stamps recently issued. Each bears a different postage and air rate. (Copyright, 1938, NFA Service, Inc.)
