

### DOCK WORKERS' TIE-UP SPREADS

SEATTLE, Sept. 9.—(UP)—A strike of members of the International Longshoremen's association (A. F. L.) against a national labor relations board order spread today to Bellingham, fifth Pacific northwest port to be affected by the tie-up.

The S. S. Coast Miller was idle in Bellingham after unloading all cargo except that consigned to Tacoma, where the strike started last week.

Ballors sympathetic with A. F. L. Longshoremen said they were watching the ship to make sure no Tacoma cargo was unloaded by C. I. O. longshoremen. The Coastwise Line, owners of the ship, said no attempt would be made to divert cargo from Tacoma.

Ships also were tied up in Seattle, Fort Angeles and Anacortes. The I. L. A. stood pat on demands for collective bargaining rights in Tacoma, Port Angeles and Anacortes, the three northwest ports in which the union has the majority of members.

### G. O. P. VICTORY SEEN IN MAINE

PORTLAND, Me., Sept. 9.—(UP)—Maine holds its "as Maine goes so goes the nation" election today, but the old political saw had lost prestige because of what happened in 1936.

Republicans claimed an overwhelming victory in advance of the opening of the polls, and the Democrats professed to be confident that they would win. They hoped privately, however, to reduce the Republican margin of victory below that of 1936 when Maine went Republican but most of the rest of the nation went Democratic in November.

Rep. Ralph O. Brewster, Republican, and former Gov. Louis J. Brain, Democrat, sought the senate seat of Frederick Hale, Republican, who is retiring.

### LONDON COUNTS TOLL IN 3 RAIDS

escort of fighter craft, appeared over London just before the supper hour. The attack started slowly but suddenly German planes were reported over many parts of the vast metropolitan area.

**600 ARE KILLED**

It did not last long enough to equal in intensity the Saturday and Sunday attacks on the British capital, which claimed an estimated 600 lives and 2,000 wounded.

There was some belief that the Germans had found a new infiltration to penetrate British defenses in strength and that they might be returning to their earlier tactics of quick sharp attacks designed to knock out the royal air force.

In Berlin, it was officially reported German aerial attacks on London again "reached a climax" today, with Nazi bombers diving through a haze to blitz military objectives and start huge new fires with "earthquake" explosions.

Meanwhile British bombers blasted back at the great German port of Hamburg and pounded heavily at German barges and shipping all around the North Sea in the last 24 hours, the air ministry revealed.

### 15 PLANES LOST

Scope of the British counter-offensive against the bases and shipping which Germany might employ in an invasion attempt was indicated by the air ministry's report that 13 British bombers were missing after the operation.

The attacks it was said were directed at key harbors and ports in France, Belgium, Holland and Germany itself.

Particularly heavy attacks were made on shipping in the ports of Dunkirk and Boulogne. Other bomber units attacked German convoys along the North Sea coast.

In Berlin the high command admitted the attack by British bombers in Hamburg which has 1,150,000 population, but said damage to military objects was slight. Berlin dispatches said the British also rained Kiel and Luebeck with "dripping" bombs "aimlessly." The Germans said that about 30 British bombers attempted to reach Berlin but were repulsed.

### HEAVY GUNS IN DUEL

LONDON, Sept. 9.—(UP)—An artillery duel between German and British long range guns across the English channel was reported officially tonight.
